In consideration of my minor child being permitted to participate in any way in the MADISON ULTIMATE FRISBEE ASSOCIATION sponsored Activities ("Activity"), I agree to the following:

1. I understand the nature of the MADISON ULTIMATE FRISBEE ASSOCIATION activities and the Minor's Experience and capabilities and believe the Minor to be qualified to participate in such Activity. I further acknowledge that I and the Minor are aware the activity will be conducted in facilities open to the public during the Activity. I further agree and warrant and will instruct the Minor that if at any time the Minor believes conditions to be unsafe, he/she will immediately discontinue further participation in the Activity.

1. I understand that by executing a Waiver of Liability, I have released the MADISON ULTIMATE FRISBEE ASSOCIATION, its officers, directors, administrators, employees, volunteers, and agents (each considered one of the "Releasees") from all liability, claims, demands, losses, or damages on my account arising in whole or in part by the minor's participation in the activities of the Madison Ultimate Frisbee Association, and any risks and dangers of SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, BLINDNESS, PARALYSIS AND DEATH ("Risks").

2.I hereby acknowledge that there may be no adult supervision, either provided by MUFA or otherwise, of Minor's participation in the Activity. Further, I understand it is my responsibility to attend and supervise any such Activity, regardless of whether an adult may or not be present.

2. Accordingly, I HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the aforementioned Releases from ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, DAMAGES, or COSTS, INCLUDING ATTORNEY FEES, RELATED TO Minor's participation in the activities of the Madison Ultimate Frisbee Association and any associated Risks.

3. I FULLY UNDERSTAND that:(a) MADISON ULTIMATE FRISBEE ASSOCIATION Activities involve risks and dangers of SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, BLINDNESS, PARALYSIS AND DEATH ("Risks"); (b) these Risks and dangers may be caused by the Minor's own actions, or inaction's, the actions or inaction's of others participating in the Activity or the condition in which the Activity takes place; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES incurred as a result of the Minor's Participation in the Activity.

3. I FULLY UNDERSTAND AND AGREE that if, despite the Release, I, the minor, or anyone on the Minor's behalf makes a claim against any of the Releasees named above, I shall be responsible for ANY COSTS INCURRED BY THE RELEASES, INCLUDING BUT NOT LIMITED TO LITIGATION EXPENSES, ATTORNEY FEES, LOSS LIABILITY, COSTS or DAMAGES pursuant to the foregoing indemnity provision.

4. I HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE, MADISON ULTIMATE FRISBEE ASSOCIATION, its officers, directors, administrators, employees, volunteers, and agents (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my account arising in whole or in part by the minor's participation in the activities of the Madison Ultimate Frisbee Association, and any associated Risks.

4. I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I AND THE MINOR HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE.

5. I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I AND THE MINOR HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY THE LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THAT THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
